## **Notes on this Draft of the OBC**

### **Outline Planning Approval**

The City Council has approved the planning application subject to the Trust reaching agreement with the Highways Agency on the design of the ambulance entrance from the A47 slip road. The consultants working for the Highways Agency have prepared a report on our proposals for the access road. The design of the road has been referred to the Highways Agency's own design team for review. Final approval is expected in mid June 2003.

The planning application for the Integrated Care Centre was discussed with the local planning officers on 5 March 2003, and submitted on 16 May 2003. The site was previously used for a health care facility of similar height and size. The planning officer has indicated that in principle he cannot see any reason for an outline application being refused.
